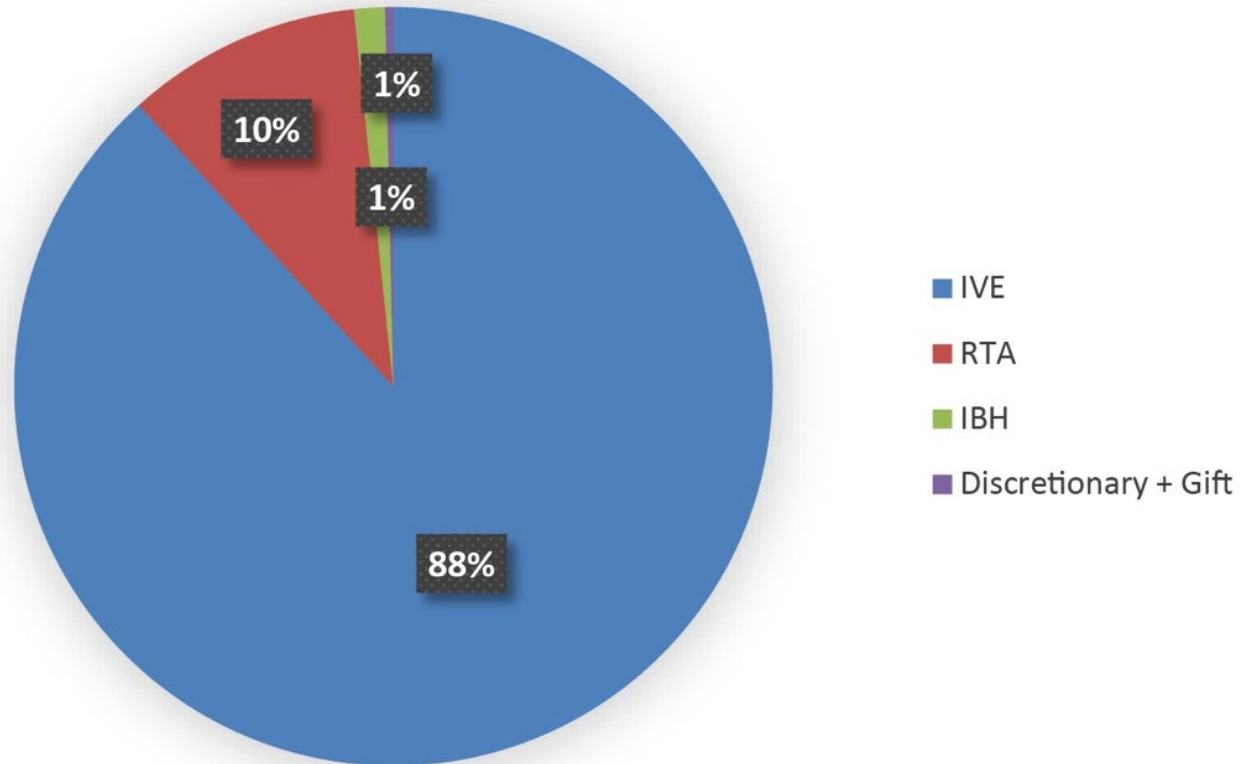

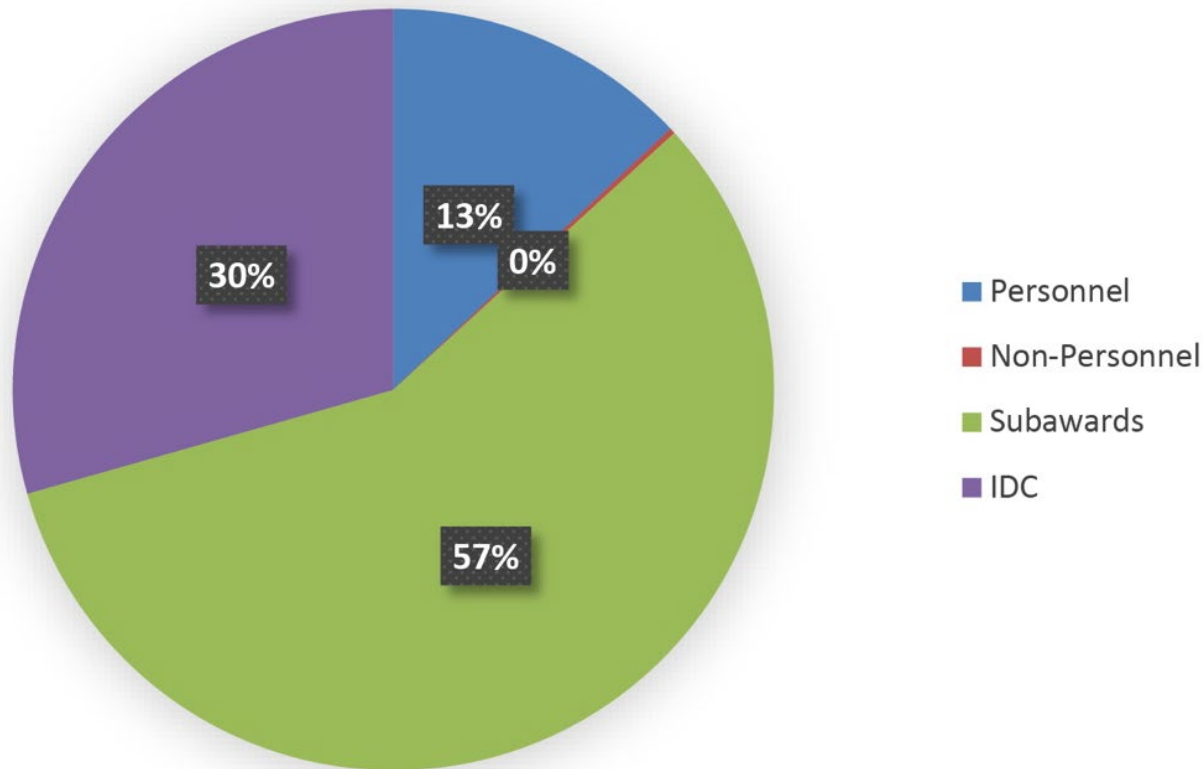
FY2122 CalSWEC Revenue

# VII. Title IV-E Program – Carolyn Shin

## ▶ FY 22–24 Contract

- Proposal submitted to CDSS end of November
- Key changes
  - Tribal Pilot – The Tribal Pilot provides stipends and scholarships for students who are Native American or members of a tribe and are pursuing a Master of Social Work degree with the intention to practice public child welfare for Tribal or county social services. This funding will augment the existing CDSS contract with the California Social Work Education Center to cover the expanded students served in the stipend program. These students may not be subject to monetary repayment.
  - Juvenile probation as qualifying agency for field placement and employment obligation.



# VII. Title IV-E Program – Carolyn Shin (cont.)

- ▶ Virtual Title IV–E Job Fair
  - 185 IV–E students; 23 agencies
  - Over 96% of attendees felt the event was effective and helpful in determining their IV–E employment
- ▶ 2022 Title IV–E Summit
  - Theme: The Impact of Intergenerational and Racial Trauma in Child Welfare
  - Two virtual sessions
    - Feb 9, 2022, 2–4:10 pm – PANEL – The Impact of Intergenerational & Racial Trauma in Tribal Communities
    - March 2, 2022, 2–4:10 pm
      - 2:10–3pm – The Intersection of Racism and Homophobia in Child Welfare
      - 3:10–4pm – Strengthening Families Using a Racial Equity Lens



# VII. Child Welfare In-Service Training Program

## – Vanessa Rezos

- ▶ FY 22–23 Contract amendment currently being drafted
- ▶ Curriculum Updates:
  - Common Core 3.5 launched July 2021. All academies have delivered at least one full cohort. Revisions will occur based on quarterly feedback
  - Supervisor Core launched January 2022
  - Continuing Training Topic: Father Engagement. CalSWEC collaborating with Northern Training Academy and CDSS



# VII. Child Welfare In-Service Training Program – Vanessa Rezos (cont.)

## ▶ Evaluation:

- Fidelity Assessment Tool Pilot January 2022 – June 2022. Data collection/ observations started on January 7. CalSWEC will be observing 30 trainings. SupCore Days 3&4, Common Core 3.5: Orientation to California Child Welfare Practice, Introduction to Child Development & Trauma-Informed Practice, and Concurrent Planning: Conversations and Documentation.
- Evaluation will be undergoing a revision. At this time we are looking at CACWT and CWS/CMS data.

## ▶ Fairness & Equity Symposium: September 2022

- Theme/Title: **Advancing Equity Through Prevention**
  - Rationale: As California prepares for a statewide prevention focus, generating collaboration across systems, the intention of this symposium is to begin the conversation through the lens of equity.



# VII. Integrated Behavioral Health Program

## – E. Maxwell Davis

- ▶ **BHWET IBH Training Program**
  - Recruiting trainees for AY 2022–23; applications are out and info sessions are underway
  - Beginning planning for 2022 IBH Symposium to be held in early May
- ▶ **MHSA Stipend Program follow up tracking continues**
  - No service/repayment extensions beyond 6–30–22; MSW program payments due then
  - White paper on retrospective study of MHSA Stipend Program finally complete!
- ▶ **Guide to MSW Field Education for Community Health Centers in press**
  - Guide must be reviewed by HRSA before publication; should be disseminated to community health centers this spring; they appear to have a great deal of interest
- ▶ **Statewide Behavioral Health Workforce Development Efforts**
  - Providing data on MSW programs and workforce needs to various workgroups
  - If your MSW Program has not responded to survey about program capacity, please do!





# VII. Adults & Aging Program

## – E. Maxwell Davis

- ▶ **Evaluation of APS Stipend Program pilot project**
  - Post-hoc project will begin as soon as contract with CDSS is fully executed
- ▶ **Statewide APS Training Program funded for 2021–2023!**
  - To be implemented at 10 MSW programs (50 trainees) in AY 2022–23 and at 12 MSW programs (60 trainees) in AY 2023–24
  - Information from Summer 2021 capacity survey used to develop plan/footprint
  - Work will begin as soon as contract with CDSS is fully executed
  - Maxwell will reach out for planning purposes as soon as contract is in place
- ▶ **Collaboration with BASSC and the Mack Center**
  - White paper disseminated in December 2020 based on statewide survey of workplace policies and practices and workforce needs in CA Adult Services units
