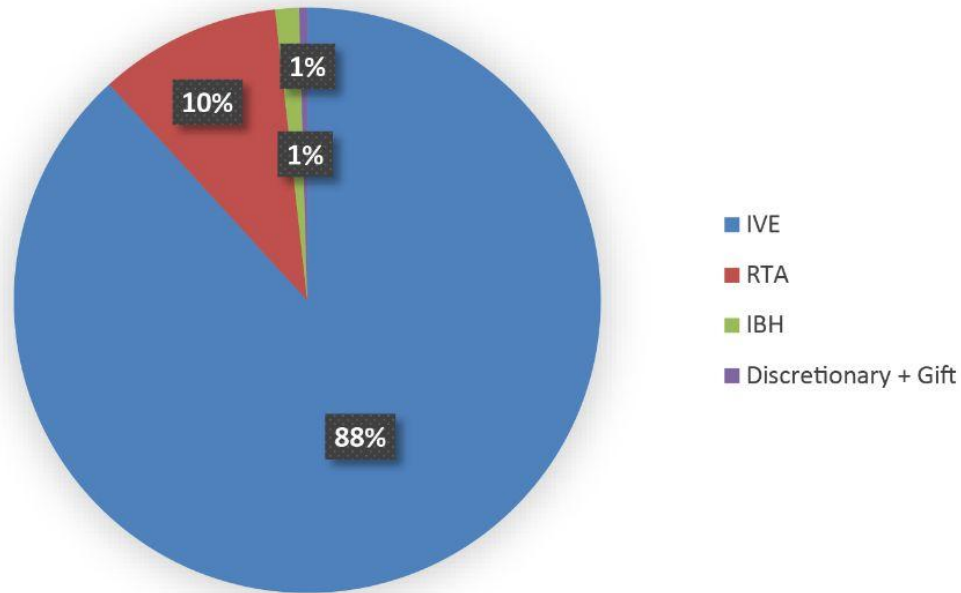

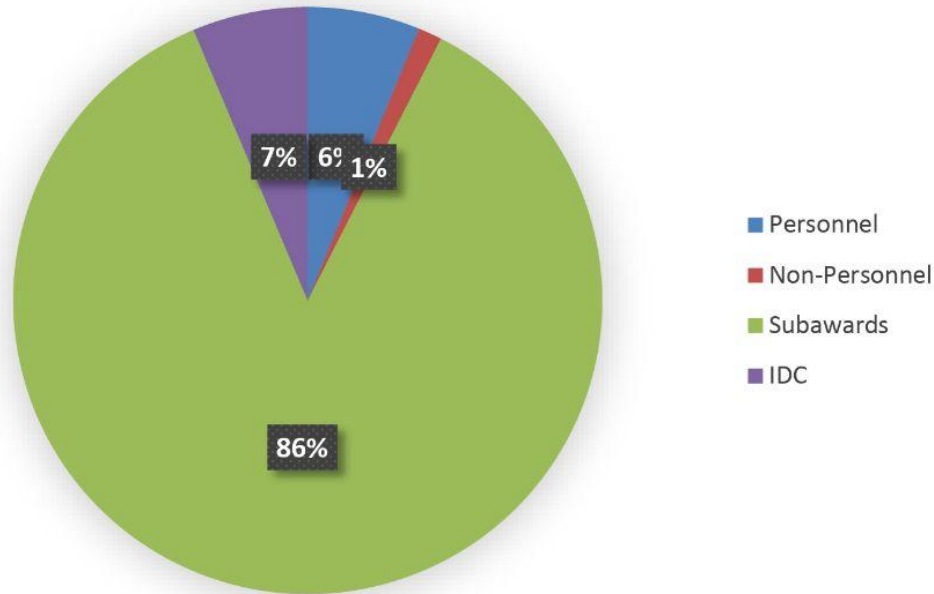

- FY 22-23 Contract amendment currently being drafted
 - CalSWEC will be working with Bay Area Academy to review curriculum with an REI Lens
- Curriculum Updates
 - **Common Core:** From January 2022–October 2022, we have revised 5 curricula which include Trainer-led, eLearning, and Field Activities. Strategic planning with the Content Development Oversight Group (CDOG)
 - **Supervisor Core:** SupDOG has finished their revisions. Now CalSWEC is working on edits, and will be launching January 2023
 - **Continuing Training:** Behavior: Engagement–Working with Fathers in CW
 - CalSWEC to draft a 3-hour skill-based curriculum

IX. In-Service Training Program (2 of 2)

Vanessa Rezos

- Curriculum Updates (cont.)
 - **Evaluation:**
 - **Common Core** and **Supervisor Core** follow-up survey in final stages
Workgroup used research to identify indicators of transfer of learning and retention, and developed items to measure associated constructs
 - **Fidelity Assessment Project:** Pilot phase I complete; analysis of phase I data complete
 - Pursuing phase 2 of the pilot. In this phase, a trainer will stage shorter sections of trainings that will be recorded that are low, medium, or high fidelity

IX. Integrated Behavioral Health

E Maxwell Davis

- **BHWET IBH Training Program**
 - AY 2022-23 training has begun, after yearly delays in finalizing funding agreement
 - Guide to MSW Field Education for Community Health Centers that CalSWEC created in collaboration with CPCA is helping more CHCs plans to offer MSW field placements
- **MHSA Stipend Program follow-up tracking continues**
 - Collection of repayments from universities for student repayment defaults continues
 - Final payments are due to CalSWEC by March 31, 2023
- **Statewide Behavioral Health Workforce Development Efforts**
 - CalSWEC is working closely with HCAI to develop a feasible agreement that will guide the new statewide behavioral health training program for MSW students
 - This program will focus on training students to provide publicly-funded behavioral health care in any setting (schools, healthcare sites, corrections sites, etc), with emphasis on the needs of children and youth and collaboration with other service systems



IX. Adults & Aging Program

E Maxwell Davis

- **Evaluation of APS Stipend Program pilot project**
 - Contract with CDSS for evaluation of the APS pilot project is fully executed
 - This post-hoc analysis will be used to shape the new statewide project
- **Statewide APS Training Program funded for 2021-2023!**
 - Announcements sent out two weeks ago to university and county partners
 - Program will be implemented at 10 MSW programs (50 trainees) beginning in AY 2023-24, at 12 MSW programs (60 trainees) in AY 2024-25, hopefully at 15 schools in AY 2025-26, and eventually at all accredited MSW programs
 - Information from Summer 2021 capacity survey is being used to develop plan
 - Maxwell will reach out to interested MSW programs for planning purposes in November; applications and other program documents will be disseminated in January, trainee selection will be completed in Spring 2023
