


FY2223 CalSWEC Q2 Revenue

 - RFA Academy Written Directives v.8 curriculum updates on track to complete by the end of the FY (beginning of June)
 - CANS workgroup: Modules being renamed to reflect the title of each course. Will more than likely be archiving Module A and D. The workgroup is working with TCOM/PRAED around an embedded evaluation.
 - Statewide vetting of Father Engagement Skills Lab (1/2 day course) will begin at the beginning of May
