Child and Family Teams are an integral way that child welfare services and mental health services will work together to support children, youth, and families. Child and Family Teams are more than meetings and need regular care and maintenance in order to be successful. Facilitators must be able to create strong yet open and evolving teams to meet the needs of children, youth and family over time. Participants will:

- Strengthen engagement skills for teams
- Develop a safe team environment
- Guide, brainstorm and create consensus with the team
- Integration of multiple plans
- Assist the team in developing, evaluating progress and revising the plan

Through practice, participants will be prepared to facilitate a successful Child and Family Team.
