## VI. CalSWEC Central Updates (cont.)

### Child Welfare In-Service Training Program

- ▶ Supervisor Core Curriculum, January 2020
  - New learning evaluation: Situational Judgement Test
- ▶ Common Core Phase III Revise in development
- ▶ CANS/Child & Family Team (CFT) Integration into Common Core, Statewide CFT Curriculum Workgroup
  - Child and Adolescent Needs and SDM Alignment
  - Statewide, Standardized CFT curriculum in development



## VI. CalSWEC Central Updates (cont.)

### Integrated Behavioral Health

- ▶ MHSa Stipend Program: 2018–19 was final year of stipends; now in tracking and reporting mode
  - We are analyzing data for the MHSa Retrospective Survey and hoping to collect a third wave of data through early 2020
- ▶ BHWET IBH Training Program is in Year 3
  - 81 trainees to date
- ▶ BHWET SUD Training Program is in Year 2
  - 11 trainees to date
- ▶ APS Stipend Program is in Year 1 of two–year pilot
  - 10 trainees to date
- ▶ Searching for new behavioral health–focused training and evaluation projects, such as LCOE eval work

- ▶ Statewide RTA Training Schedule launched
- ▶ Statewide Learning Management (LMS) in the needs analysis phase
- ▶ Online Field Instructor Training in development
